Our membership comprises men and women of all races, creeds, social and economic standing and ideologies. While we have many differences, the one thing we all share in common is the fact that once upon a time, we all raised our hands and swore a solemn oath to protect and defend the Constitution of the United States. There was no time limit mentioned when we took that oath, and accordingly, it remains binding.

The first sentence of the Constitution begins with the words, "We the People of the United States, in Order to form a more perfect Union ..." The authors and signers did not imply they were creating "a perfect union" or "the perfect union"; they instead chose to pen "a more perfect union." I believe they knew from the beginning that what they fashioned was a work in progress. And I believe that from its beginning, We the People have and continue to struggle for the perfection that remains the ideal that our founding fathers sought. While we have and continue to struggle towards a more perfect union, it is important that we recognize that the tools to bring about needed change were purposely embedded in our first binding compact — the Constitution of the United States.

The right to protest exists in America because the Constitution provides us with such right. Protests take place in America because it is too often the only way to bring attention to the need for change. In every protest I have lived to see in America, not one has called for abolishing our Constitution

— they have demanded that we pay attention to what it already says.

The path to change is sometimes scary and, unfortunately, it is sometimes bloody. Certainly, we don't have to agree to take any path lain before us. But it is important, I think, to remember that it is the right to propose such paths that we have sworn an oath to protect and defend and, indeed, laid pavement to with blood and sacrifice. While we have yet to find that perfect union, we are dutybound to preserve safe passage for all who seek to find it, even those we may feel are misguided. What has made the Constitution of the United States the oldest constitution in the world is the humility in its words. It seeks to provide and protect forums for change, knowing that change is, and will always be, the path to perfection.

This month, we were asked to fulfill the obligation democracy demands of us through our election process. It is my hope that you voted for the candidates of your choice November 3rd.

This month, too, we took the time to recognize the service all Veterans who have, since our beginning, served, fought and died so that all people have the right to cast their vote. On the 11th month, upon the 11th day, we remembered the oath we shared, the comrades we lost, the service we gave and the freedoms and liberties we help to protect and defend.

# **GENERAL NEWS ITEMS**

### **DAV 84 to Launch Mobile Accessibility Program**

DAV 84 officers unanimously approved a motion to begin a Mobile Accessibility Program (MAP) that will provide disabled Veterans with electric scooters, wheelchairs and other devices needed by them to restore their ability to travel, shop and enjoy activities in their communities.

MAP will undertake to acquire mobile electric scooters, wheelchairs and other devices that will be loaned at no cost to Veterans who require such aids for as long as they are needed. Because the items will be on loan to each Veteran, DAV84 will undertake to service and repair all the loaned devices at no cost to the Veteran using the device.

Each mobile scooter will be custom painted with patriotic colors to denote that it is in use by a disabled Veteran. The Veteran will have the device delivered to their home and receive training on use of the device. Regular maintenance of the scooter will be done by DAV84 volunteers, as will any repairs needed over the lifetime of the scooter or other device.

Veterans requiring temporary use of wheelchairs, or who prefer a wheelchair over a scooter will also be accommodated. Crutches and canes will also be made available to Veterans requiring temporary support.

The program is set to launch in January 2021. Applications are now being accepted. DAV84 members will receive first priority on issuing scooters, followed by disabled Veterans in other Illinois areas. Because of the need to service the devices at each user's location, the program is initially set to accommodate the needs of Veterans within a 50-mile radius of the DAV84 headquarters in Crestwood, Illinois.

# **NSO REPORT**

For almost a century, DAV has been advocating for better federal veterans programs, benefits, health care and transition services for the men and women who served, their families and survivors. DAV's National Legislative Department takes the resolutions adopted by DAV members at our annual National Conventions to Congress to advocate for improved federal laws, regulations and policies of the Department of Veterans Affairs (VA) and other federal agencies whose programs support the veteran population.

In the 115th Congress, a number of DAV's key legislative priorities were enacted, including the historic VA MISSION Act, a bill to reform and strengthen the VA health care system and expand VA's caregiver program to all eras of veterans. In addition, new legislation was approved to modernize the claims and appeals process, and improve earned benefits for veterans, their families and survivors.

For the second session of the 116th Congress, DAV is actively working to achieve these five Critical Policy Goals:

- Toxic exposures
- Enhance survivor benefits
- Fully and Faithfully Implement VA MISSION Act of 2018
- Strengthen Veterans Mental Health Care and Suicide Prevention Programs
- VA's Women Veterans Health Care Program

Please stay tuned for developments in these crucial discussions.

## **AUXILIARY**

Did you know that our full chapter name is: Disabled American Veterans, Alfred Grajek Tricentennial, Chapter 84?

Alfred Grajek, who our chapter is named after, served in the Army Air Corp during World War II as a Radar Technician in the India-Burma Theater. Following the War, Al became an active member of several veterans' organizations including the DAV. He was named the 50th Imperil Golden Rodent of the National order of Trench Rats – an honorary order founded by disabled veterans following the first World War. Al was also a Department Commander of the DAV and played a significant role in bringing the Eternal Flame Veterans Memorial to Worth, Illinois. He was a long time barber and owned the Veterans Barber Shop originally in the Roseland area of Chicago, and then in suburban Worth. Al passed away of a heart attack while attending the dedication of the Abraham Lincoln National Cemetery. His name was adopted by our Chapter in honor of his work for veteran causes.
