One bill passed into law Veterans Mental Health Care Improvement Act—Public Law 116-171—into law in October 2020 Veteran Mental Health bill which is a comprehensive approach to connect veterans for suicide prevention.

# **Proposed Legislation Jan 2021**

**H.R. 333**Introduced: January 15, 2021 Sponsored By: Rep. Sanford Bishop Jr., Georgia (D)

This law would amend title 10, United States Code, to permit concurrent receipt of both military retirement pay and VA compensation for service-connected medical issues for those who are VA-rated as 50% or less service-connected disabled. The House Resolution would extend eligibility "for concurrent receipt to chapter 61 disability retirees with less than 20 years of service" and other purposes. This bill is currently under

review by the House Armed Services Committee and the House Committees on Veterans Affairs.
